- II. President Anita Pineda: Welcomed everyone to the tenth, Emergency Chapter Meeting. She clarified that this meeting is still part of the 2020 Season and that the New Season Meetings will start on Wednesday, June 2, 2021. The purpose of this meeting was to announce that BISD middle school volleyball season will start in May. There will be three weeks of games with split sites. We will still follow CDC Guidelines. BISD Athletics are still working on the details, there will probably be A and B teams only with possible cancelation at the last minute.
