## **Every 32-AAA Coach:**

Strives to develop and maintain a comprehensive athletic program which seeks the highest development of all participants, and which respects the individual dignity of every athlete.

Considers the well-being of the entire student body as fundamental in all decisions and actions.

Supports the principle of due process and protects the civil and human rights of all individuals.

Organizes, directs, and promotes an interscholastic athletic program in harmony with, and contributes to, the total school program.

Cooperates with staff and school administration in establishing, implementing and supporting school policies.

Acts impartially in the execution of basic policies, and the enforcement of the district and U.I.L. rules and regulations.

Fulfills professional responsibilities with honesty and integrity, actively representing the district at U.I.L. district meetings and district competitive events.

Upholds the honor of the profession in all relations with students, colleagues, coaches, administrators and the general public avoids using the position for personal gain or influence.

Seeks to improve the professional status and effectiveness of the interscholastic program through participation in local, state and national in-service programs.

Is committed to high standards of ethics, sportsmanship, and personal conduct among the members of the coaching staff and the athletes representing their school, assuring that proper respect is exhibited toward officials, opponents and their property.

## TO: ALL USERS OF 32-AAA ATHLETIC PLANS

Appreciation is acknowledged for the Coaches and Athletic Directors that participated in upgrading the Athletic Plans for the 2023-2024 school years. Adherence to the plans is suggested as a means to avoid problems. It should also be understood that National Federation Rules and the University Interscholastic League Rules supersede these plans. Users are urged to be familiar with all applicable rules and to report any inconsistencies to their respective Superintendent or the Chair of the Executive Committee. Additional modifications may be made as the needs arise. This process must be approved by the Districts Executive Committee.

The 32-AAA participants take pride in respecting the right of all athletes to compete according to the same set of rules in an impartial setting. Fairness to all concerned will result in the quality of athletes that we strive to develop.

#### RECOMMENDED PROCEDURES

In order to avoid confusion and problems with the submittal of required information, the administrator in charge for each district should comply with the following:

- Submit certification forms and agenda on official forms provided by U.I.L. Typing all forms is required.
  - The Chair of the Executive Committee subject to ratification by the Executive Committee will approve all forms requiring committee action.
  - The individuals indicated should sign the forms. This is especially sensitive relative to students who have participated previously in athletics in other districts.
  - Observe the chain of command within the limits of each district.
     Superintendents, High School Principals and Athletic Directors are encouraged to resolve problems whenever possible.
  - Official communications with the chair of the Executive Committee are reserved for the Superintendents, High School Principals and Athletic Directors.
  - 32-AAA individual schools will police their own sub-varsity teams. Seniors shall be allowed on sub-varsity teams.
  - Sports organizational meetings (if necessary) prior to the start of each sport will be held at school assigned to that particular sport.
     (Refer to 32-AAA assignments on page 61)
  - Rescheduling of new game dates will only be allowed for the UIL and extracurricular scheduling conflicts.
  - Varsity eligibility forms certified by the superintendent or designated administrator must be submitted prior to the first contest to the chairman of the district executive committee. All PAPF approvals/disapprovals shall be reported by the district chair to all schools involved.
  - The home team of all sports will fax or email game scores to the district chair the next school day after play.

Video cameras may be allowed at 32-AAA athletic events in accordance to the UIL Constitution and Contest Rules section 1208:m.1.B; registration of video cameras will be left up to the discretion of the host school.

These procedures are simple yet provide the structure necessary to operate the 32-AAA functions with some semblance of propriety. The added responsibilities brought upon the District Chair can be minimized if these procedures are used.

# DISTRICT 32-AAA ATHLETIC PLAN

## **FOREWORD**

Each school shall be assessed a fee for the purpose of purchasing a trophy for the district winner, and to defray expenses of the district chairman. Only one trophy will be bought for the team representing the district in the playoffs. The runner-up teams representing the district shall not be awarded a trophy at the expense of District 32-AAA. The district chairman will pay all regional fees.

## **District Fees**

\$4,500 – UIL Athletics – HS Only \$1,200 - Middle School

All district athletics fees are utilized for the purchasing of trophies, medals, ribbons, and any other fees incurred in the organizing and participation of all schools in District 32-3A championship events. Deadline for fees is September 20, 2024

Penalty for non-payment of District fees by deadline may result in forfeiture of Championship titles and post-season advancement.

In the case of Cross Country and Track & Field district meets, District 32-3A will pay for medals, meet officials, timing company (High School events only), ambulance service, and coach/worker meals. All other fees are to be covered by the hosting school.

At the end of every year, the DEC will meet to discuss any surplus of funds after all line-items are paid for the fiscal year and determine the best outcome for the funds remaining.

## ADMISSION TO ATHLETIC EVENTS

## HIGH SCHOOL VARSITY

(Volleyball, Basketball, Track, Baseball, Softball, Soccer)

#### SUB-VARSITY

(Volleyball, Basketball, Track, Baseball, Softball, Soccer)

Adult \$4.00 Student \$2.00

The Athletic Director of the 32-AAA chairman's school shall be responsible for issuing **50** District Passes for all athletic activities and will be issued to each district school. These passes will allow admission of pass holder and one guest (1).

General admission student is defined as anyone enrolled in grade Pre K-12.

For the reserved section - Anyone who occupies a seat in the reserved section needs a ticket regardless of age.

## Play-Off Structure

- A. Best won-lost percentage district record to be declared champion.
- B. Second best won-lost percentage district record to be declared second place winner.
- C. Third best won-lost percentage district record to be declared third place winner.
- D. Fourth best won-lost percentage district record to be declared fourth place winner.
- E. Any tie can be resolved by coin flip by mutual agreement.
- F. If there is a two-way tie and one team has won both mutual matches, then that team is designated "first seed" for play-off purposes. The other tying team will be designated "second seed". Both teams shall be declared co-champions.

- G. If there is a two-way tie and each tying team has won a mutual match, then there will be a play-off between those two teams. The winner will be designated as "first seed". Both teams will be declared co-champions. The schools concerned will arrange play-off factors. There will be a one-game play-off. (If both teams disagree to play, there will be a coin flip to decide whether they will play or not play. If the coin flip determines that the two teams will play, there will be another coin flip to determine the home site.)
- H. If there is a two-way tie for second place and each tying team has won a mutual game, there will be a single elimination play-off game to determine the second seeded team. If there is a two-way tie and one team has won both mutual matches, then that team is the district second seeded team. The other team would be the third seed representative.
- If there is a multiple tie among three or more schools, there will be a district play-off tournament to determine the first and second seed representative. However, if one team is undefeated in those mutual games among them, that team will represent the district as "first seed". The same principle will apply to the remaining teams. (This will be known as the "won all mutual games" principle.) In the case of no team having won all their mutual matches, then the tournament play-off format shall be applied. Teams involved will be recognized as district champions. Mutual agreement flips. Refer to "I" for mutual agreement flip procedure.
- J. Head to Head records will determine playoff spot. If three teams tie for first (A, B, C, example): Flip to determine bye with odd man drawing the bye.
  - 1. A draws a bye, B plays C. C defeats B. C plays A and A wins. A is the first place seed and C is the second place seed.
  - 2. A draws a bye and B plays C. C defeats B. C plays A and C wins. C is declared the first place seed, but A must play B to determine the second place seed.
- K. If four or more teams tie for first, a single elimination play-off tournament determined by lot (draw) will determine the first and second place teams. Teams involved will agree upon site, time and officials.
- L. In case of multiple ties for second and/or third place, the principle described in sections I, and J will apply.

## 32-AAA RULES FOR ALL-DISTRICT SELECTION

- A. Selection for All-District teams in 32-AAA will be in a uniform manner.
- B. The District Champion, in each respective sport, will have the option to host all-District selections, on the 2<sup>nd</sup> Wednesday or Thursday after the District certification deadline or on a date and time mutually agreed on by Athletic Directors. If the District Champion declines, the last place team will host. Athletic Director/Athletic Coordinator and Head Coaches of sports will be allowed to attend a selection meeting during school hours.
- C. All-District Selection meals may be provided through District funds not to exceed \$10.00 per person.
- D. Hosting schools will pay the vendor, then submit to DEC for reimbursement or make arrangements with DEC for vendor payment with ample time.
- E. The head coach will nominate his own players on 32-AAA approved ballots. Nominations can be emailed at least 2 days PRIOR to the all-district selection meeting. In superlative awards the coach will nominate one player per team, MVP, Defensive Player, etc.
- F. No athlete should be denied an All-District nomination due to prior game/meet ejection.
- G. The host school will provide clerical help as needed. Ballots will be completed after all head coaches have arrived at the site of the meeting.
- H. Each position will be treated as a separate vote.
- I. Each coach will vote for a position. (You must vote.)
- J. Any player selected as most valuable, newcomer, or player of the year will not be included on the first team. An athlete can only win 1 award during all district selection.
- K. Coaches will vote for opponents' players only. As indicated on the ballot, the number of individuals to be selected for each position will be voted on as follows:
  - All first team selections will be given a 2 point vote (2).
  - All second team selections will be given a 1 point vote (1).

- L. First team selections will be those receiving the **most points** for the available positions. The second team will be those receiving the next most points for the positions available.
- M. Any tie for any team will not be broken. Tied players will be included on the appropriate team.
- N. Honorable mention will be given to any player receiving at least one point.

  Additionally, each team may place as many players on the honorable mention list.
- O. Coach of the year will be the coach of the district champions.
- P. All-District teams will not be announced until the last 32-AAA team is out of the play-offs.
- Q. Newcomer of the year is anyone who has participated in at least half of the district games.
- Q. All District Selection Meetings will start on time unless extenuating circumstances arrive. Head coach or designee and no more than two assistant coaches will be allowed in the All-District Selection meeting. The Head Coach or designee will be the only one who can discuss athletes at meetings. A time limit of 30 seconds will be allowed to discuss athletes. Each school MUST have a representative at the selection meeting.
- R. The District Champion Athletic Director/ Coordinator must attend and monitor the All District selection. **All Athletic Directors/Coordinators are encouraged to attend.**

All-Academic Team w/GPA of 90 or Better will be recognized at the All District Selection Meeting.

## DISTRICT 32-AAA VOLLEYBALL PLAN 2023

1. District volleyball matches will be played on Tuesdays' and Saturday's in the high school gyms on a home and home basis. Friday games will be required (discretion of the coaches) in order to accommodate athletes that split time between band, cheerleading, cross country, etc. No Saturday game will start any earlier than 12:30 pm.

## 2. GENERAL RESPONSIBILITIES

- a) Home School must provide at least one uniformed security person for Varsity games.
- b) Home School must provide proper and private dressing facilities for opponents.
- c) Home school must provide and designate at least one AED/CONCUSSION MANAGEMENT/CPR/1<sup>ST</sup> AID CERTIFIED Professional for Varsity games.
- d) For varsity games one adult lines judge will be provided by each team.

## 3. STARTING MATCH TIMES:

Tuesday's & Friday's
Freshman/JV Light 5:30 p.m.
J.V. 6:00 p.m.
Varsity 7:30 p.m.

Saturday's
Freshman/JV Light 12:30 p.m.
J.V. 1:00 p.m.
Varsity 2:30 p.m.

- 4. If no freshman team, start time will be JV 5:30pm and Varsity 7:00pm. If there is no JV team, then Varsity will start at 5:30pm.On Saturday, if there is no freshman team, game time for JV will start at 1:00pm. Unless, a different time was discussed by mutual agreement and the home team notifies entire district.
- 5. On Friday games, Varsity will have the option to play first to accommodate cheerleaders, band and student trainers, etc. If Varsity plays first, JV will play next, with Freshman playing last.
- 6. Varsity matches will be 3 out of 5 (no cap), 5<sup>th</sup> game to 15 (no cap), **must win by 2 points**. The let serve shall be allowed.
- 7. Sub-varsity matches will be 2 out of 3 to 25 (cap at 30), with 3<sup>rd</sup> game being played to 15 (cap at 20) the let serve shall be allowed.
- 8. \*Change of date and/or times of matches will be by mutual agreement of both schools. Prior to the match, Home team needs to inform the District Chair and all Head Volleyball/Athletic Directors of the change of dates and/or times and the chapter officials. \*
- 9. Only official volleyball will be used as set out in the UIL rules. Home Team will provide a NFHS approved game ball. Home Team will provide the visiting team with at least 12 warm-up balls and cart
  - during the Varsity's match when at the net. Water will be furnished by the home team.
- 10. Officials / Officials "no show"
  - A. Varsity games require a two-man crew from the official assigned chapter. If only one official shows, the game will be played only by mutual agreement of the two coaches. If the coaches do not agree, they must adhere to 32-AAA Volleyball Plan. For sub-varsity games,

local officials, or a coach from the home school can officiate. JV games must be played if at all possible.

- B. If there are no officials for a game, the game needs to be played on next available date. Coaches will determine the next available playable date and adhere to the UIL rule.
- C. If a scratched official shows up to call, the school that scratched the official has the option of re-scheduling the game for the next available date. The school must have documentation of the scratch and the date scratched. Initial Scratch list must be made by <a href="August?2023">August? 2023</a> Additional scratches may be added and submitted to District Chair and all District opponents.
- D In case where conflicts arise due to school related issues, by weather or public disaster; the two schools involved may reschedule their game earlier in the week or at the latest on Saturday of the same week. Any rescheduling of games for the above reason must be conveyed to the rest of the schools in the district.
- 11. Each school shall provide one coach/adult as a line judge for the Varsity Match. Each school shall provide one player/adult responsible as a line judge for each sub-varsity match. Varsity line judge cannot be related to a player on the team.
- 12. The official scorekeeper, libero tracker, and clock operator **MUST BE AN ADULT**, out of high school, for varsity games only. Sub-varsity adults preferred, but players may be used to help.
- 13. Varsity eligibility forms certified by the superintendent or designated administrator must be submitted prior to the first contest to the District 32-AAA chairman of the district executive committee as per U.I.L. rules.
- 14. START DATES:
- A) First day of official practice is July 31, 2023
- B) First day of scrimmages is August 4, 2023
- C) First day of inter school games is August 7, 2023

## 15. PRE-GAME WARM-UP TIMES:

VARSITY: (18 minutes) Warm-up 5 minutes

Visiting Team 5 minutes at net

Home Team 5 minutes at net 8 minutes serving

Sub-Varsity: (11 minutes) Warm-up 3 minutes

Visiting Team 3 minutes at net

Home Team 3 minutes at net Both Teams 2 minutes serving

#### 16. GAME EXPENSES

- a) The home team will pay for all game expenses. All concession rights, radio and television receipts belong to the home team. (No guaranteed split)
- b) In the event of a play-off seeding game within the district, the home team will

keep all receipts.

- c) Admission prices are as follows:
  - i) Adults = \$4.00
  - ii) Students = \$2.00

## 17. GAME PASSES

- a) Visiting pep squad, bus drivers, and cheerleaders in uniform will be admitted free. There will be no limit if they are in uniform. Home administration will be responsible for securing a section. Please notify the visiting teams Head Coach of special events that might occur (Parents Night).
- b) The UIL district passes issued will be valid for all Volleyball games.

## 18. VIDEO TAPING

- a) The home team should provide adequate space for the visiting teams' video crew.
- b) One school camera per team.

## 19. MUSIC

- a) Live music and/or taped music can be played during pre-game, half-time, and time outs. It will not be permitted any time the clock is running.
- b) No bands are to play in the gym during the course of a game. Before the game and during halftime are the only exceptions.

## 20. PARTICIPANTS

- a) Only officially dressed personnel may lead or participate in any activities on the gym floor prior, during, or after the game.
- 21. A district team will not exchange tapes of another district team with an opponent outside the district during post season play.
- 22. A home team can have a short program on a school night as long as opponents are notified prior to the match
- . Suggesting Parents night to be done during a Non-district game instead of District play or to not exceed 20 minutes

### 24. TROPHIES

The championship (co-champion) trophy will be purchased by the District Committee.

## 25. ALL DISTRICT TEAM

- a. All Head Volleyball coaches will meet on a date and time mutually agreed on by the Athletic Directors at the District Champion's site. If the District Champion declines, the last place team will host.
- b. The head coach will be allowed to bring one assistant to the meeting. The Athletic Director of the District Champion shall be in attendance. An All-Academic Team will be selected. All varsity athletes from each school with a minimal GPA of a 90 will be selected. All District selections will not be released until all District teams have been eliminated from the playoffs.

- c. Use a District nomination ballot. Any player receiving votes on any of the specialist awards will automatically receive the honorable mention award if not selected for another award. Coaches are not allowed to vote for their own players.
- d. Positions to be selected for volleyball are as follows:
  - a.) Most Valuable Player
  - b.) Newcomer of the Year
  - c.) Libero of the Year
  - d.) Setter of the Year
  - e.) Offensive Player of the Year
  - f.) Defensive Player of the Year
  - g.) 1st team- Select 6 Ties Stay
  - h.) 2<sup>nd</sup> team Select 6 Ties Stay
  - i.) Honorable Mention Each school may only add two deserving players
  - j.) All Academic: GPA of 90 or better
  - k.) Coach of the Year (winning coach of the district)

TIES WILL RESULT IN CO – MVP, NEWCOMER, OFFENSIVE, AND DEFENSIVE PLAYERS OF THE YEAR.

## 26. CONCLUSION OF THE GAMES

- e. Teams will shake hands immediately after the game.
- f. Teams will follow post game procedures for the safety of athletes, coaches and officials.

#### 27. ELIGIBILITY

a. Eligibility will be based on the state adopted guidelines of UIL high school competition.

#### 28. SUB VARSITY GAMES

- **1.)** Junior varsity and freshman teams will play a complete schedule with the Varsity teams on Tuesdays and Fridays.
- 2.) Ties for places stand, as there will be no playoffs at the sub varsity levels.
- 3.) Eligibility will be based on the state adopted guidelines for UIL high school competition.

## 29. DISTRICT TITLE and TIE BREAKERS (Playoff Structure)

- a) Best won-lost percentage district record to be declared champion.
- b) Second best won-lost percentage district record to be declared second place winner.
- c) Third best won-lost percentage district record to be declared third place winner.
- d) Any tie can be resolved by a coin flip by mutual agreement.
- e) If there is a two-way tie and one team has won both mutual matches, then that team is designated "first seed" for playoff purposes. The other tying team will be designated "second seed." Both teams shall be declared co-champions.
- f) If there is a two-way tie and each tying team has won a mutual game, the two teams may flip a coin to decide the seeding or may play a tie-breaker game to decide the seeding. If both coaches do not agree on flipping or playing, a coin flip will be used to decide. The winner will be designated as "first seed." Both teams will be declared co-champions. The schools concerned will arrange playoff factors. There will be a one game playoff.

- g) If there is a two-way tie for second place and each tying team has won a mutual game, the two teams may flip a coin to decide the seeding or may play a tie-breaker game to decide the seeding. If both coaches do not agree on flipping or playing, a coin flip will be used to decide. - 1. "A" draws a bye, "B" plays "C". "C" defeats "B". "C" plays "A" and "A" wins. "A" is the first-place seed and "C" is the second-place seed with "B" being the third-place team.
- 2. "A" draws a bye, and "B" plays "C". "C" defeats "B". "C" plays "A" and "C" wins. "C" is declared the first-place seed, but "A" must play "B" to declare the second-place seed. Winner of "A" and "B" will be declared second place and the loser will be declared third place.
- j) If four or more teams tie for first, a single elimination playoff tournament determined by lot (draw) will determine the first, second, and third place teams. Teams involved will agree upon site, time, and officials.
- k) In case of multiple ties for second and/or third place, the principle described in sections "I" and "J" will apply.

The All District Team will be sent to the District Executive Committee Chairman and will be announced on the Sunday following the elimination of the last team from District 32-AAA in the playoffs.

- 2. CHAMPIONSHIP STRUCTURE The top 3 teams and top 10 individuals in the varsity divisions shall qualify from district to regionals. An individual's qualifier may also be a member of a qualifying team.
- 3. DISTANCE
- A. Varsity Girls will run 3200 meters
- B. Varsity Boys will run 5000 meters
- C. JV boys will run 5000 meters, JV girls, and all freshmen 3200 meters.
- 4. ENTRY LIMITATIONS A minimum of five participants and a maximum of seven participants shall constitute a team. Only the first five members of the team will count for the total team score. A school may enter less than five runners; however, it cannot compete for a team title. In high school no seniors will be allowed to run on the JV level. A school may enter only one boys' team

and one girls' team to compete for the district title. There is no limit on the number of participants in the JV/freshmen.

- 5. NUMBER OF MEETS Number of Meets. No student representing a participant school shall participate in more than eight meets during the school year, excluding one district meet, the regional meet and the state meet. Each meet a school team enters counts as one meet for each participating individual. Students are considered to be representing their school if they are wearing and/or using school equipment or being directed or transported by a school employee. Meets which are limited to three or fewer schools, do not count as a meet for participants, provided there is no loss of school time.
- 6. TIME AND SITE Time and site of high school district meets shall be determined by the hosting school (2023 Riverview)
- 7. CERTIFICATION TO REGIONAL MEET Individual schools certify entries via email to the regional director. The district meet director will also certify the top three teams and top 10 individuals in the varsity divisions to the regional director.
- 8. QUALIFIERS Each school qualifying a team may enter seven runners and three alternates to the regional meet. Each school is responsible for emailing their entries to the regional director so the names of the alternates can be included. Districts can only enter the top ten individuals and top three teams in the varsity divisions.
- 10. MEET DIRECTOR The meet director/UIL official is responsible for and has full authority for the management of the district meet.
- 11. MEET REFEREE The athletic directors or designee/UIL official shall have final authority on all rulings based on the rules presented in the National Federation Track and Field Rules.
- 12. DRESS REGULATIONS Contestants may not wear caps or toboggans. They may use string, rubber bands or tape to keep hair in place. Above items may be permitted during inclement weather. If a leotard or body suit is worn, shorts must be worn over them.
- 13. BLOCK ASSIGNMENTS Block assignments are drawn by the schools at 5-day prior meeting.
- 14. REPORT TIME All runners must be ready to run at the scheduled time and should report to the start area at least 10 minutes prior to the start of the race.
- 15. COURSE All runners shall be instructed to follow markings, which outline the course. Course maps will also be made available.
- 16. STARTING The command will be "runners set", when all runners have come to a still position the starter will fire the pistol. If a runner falls **DUE TO CONTACT** with another runner or an unfair start occurs, the runners will be called back by firing a second shot. In accordance with Federation rules any runner who false starts shall be disqualified.
- 17. CHUTE PROCEDURES Chute inspectors will supervise the runners once they have entered the chute. Runners shall remain in their order until they have exited. The runners will be handed a score card according to their order of finish.

- 18. UNIFORMS The cross-country uniform consists of a minimum school issued jersey and shorts, which are not objectionable, and shoes. Each member shall wear the same color and design school uniform jersey and trucks. When other apparel is worn under the uniform by more than one team member, the apparel must be the same color ex. Under armor, t-shirts, etc... A contestant must properly wear the assigned bib number if numbers are used.
- 19. RULES Cross country rules currently found in the Federation handbook shall be enforced.
- 20. DETERMINING TEAM SCORERS Scoring shall be as shown in the table below:

Place at finish  $1^{st}$   $2^{nd}$   $3^{rd}$   $4^{th}$   $5^{th}$  etc. Points 1 2 3 4 5 etc.

Competitors finishing the race shall be ranked and tallied in accordance with the above table.

The team score in each conference shall be determined by totaling the points scored by the first five finishers of each team. The team scoring the fewest number of points is the winner.

If fewer than five competitors from the school finish the race, the places of those competitors are disregarded in determining the team scores. Although the sixth and seventh place finishers do not score points in the team total, their place is counted in determining the scores of other teams.

Ties in team scoring shall be resolved by comparing the sixth-place finishers from the tied teams. The team with the best 6<sup>th</sup> place finisher shall prevail. If one team does not have a sixth-place runner, the team with a sixth place runner shall prevail. If tied teams each have only five runners, the tie will be resolved by scoring the first four finishers of each team.

## 21. CROSS COUNTRY SEASON -

An official starting date has not been set by the Legislative Council.

## DISTRICT MEETS

MEETS - Districts that have more than two boys' and/or two girls' cross-country teams or more than five individual boys' or five individual girls' entries, conduct a district meet.

DATES – The district meet will be held on Wednesday the week of district certification or on Saturday of the previous week before District Certification.

ENTRIES – Each school may enter seven boys and seven girls to a district meet on the Varsity level.

SPECTATORS - Spectators must stay off the course as marked, away from the starting line and finish line, and in roped areas to avoid interfering with any aspect of the race.

RESULTS - Final results will be e- mailed and/ or faxed to each school participating in the meet. Times and places for award winners will be posted after the race has concluded and the team points totaled.

# DISTRICT 32-AAA BASKETBALL PLAN 2023-2024

## **BASKETBALL**

## GENERAL RESPONSIBILITIES

- a) Home School must provide at least one uniformed security person for Varsity games.
- b) Home School must provide proper and private dressing facilities for opposing teams.
- c) Home school must provide and designate at least one AED/CONCUSSION MANAGEMENT/CPR/1<sup>ST</sup> AID CERTIFIED Professional for Varsity games.
- d) Home school must provide ONE athletic trainer, or have emergency action plan if no trainer can be provided

#### OFFICIALS

- a) TASO officials will be used for all Varsity, J.V., and freshman games. If coaches cannot mutually agree on TASO officials, UIL guidelines will be followed. All schools will have the option to choose any chapter of officials as long as they are certified. Two officials as designated by the home team will be used.(\*District games) 3 may be allowed if school budget permits, or approves.
- b) Varsity games require at least a two-man crew from RGV TASO Chapter Officials. If only two official shows, the game will be played. For sub-varsity games, local RGV TASO, or a coach from the home school can officiate. JV games must be played if at all possible.
- c) If there are no officials for a game, the game needs to be played on the next available date. Coaches will determine the next available playable date and adhere to the UIL rule.
- d) The home team must provide a timer and scorekeeper in district competition. It must be an adult familiar with using the clock and scorebook. Expenses of timer and scorekeeper shall be paid by the home team.

- e) The coaches of each team (all levels) will be responsible for entering full names and numbers of each athlete in the Official Score Book unless the Official Score Keeper decides to take the responsibility of doing it themselves.
- f) Home school (as per UIL) must provide and appoint a game administrator.
- g) The home team must section off two rows behind the visiting team for the visiting sub-varsity teams to sit.

## 3. GAME BALL AND PRE-GAME WARMUP

- a) The home team will furnish 8 practice balls (4 for each team), plus one game ball for Varsity and Sub-Varsity teams. The home team will also provide water and VISITING WILL NEED TO PROVIDE OWN CUP/BOTTLES.(\*HOME will provide)
- b) Warm up times for Varsity teams will be (min.) 12 (max) 15 minutes (Varsity), 10 Minutes (J.V.), 10 Minutes (9<sup>th</sup>), and 12 minutes for transportation problems that may exist. Coaches, please give each other a courtesy call when any type of transportation problems exist so officials may be made aware of the problem. (\*Time start when both teams ON court)

## 4. JERSEY

a) The home team will wear light jerseys and the visiting team will wear dark jerseys.

#### GAME EXPENSE:

- a) The home team will pay for all game expenses. All concession rights, radio and television receipts belong to the home team. (No guaranteed split)
- b) In the event of a play-off seeding game within the district, the home team will keep all receipts.
- c) Admission prices are as follows:
  - i) Adults = \$4.00
  - ii) Students = \$2.00
- d) Changes to online sales from Football Basketball \*price for example:Santa Rosa

## 6. GAME PASSES

- a) Visiting pep squad, bus drivers, and cheerleaders in uniform will be admitted free. There will be no limit if they are in uniform. Home administration will be responsible for securing a section. Please notify the visiting teams Head Coach of special events that might occur (Parents Night).
- b) The UIL district passes issued will be valid for all basketball games.

#### 7. VIDEO TAPING

- a) The home team should provide adequate space for the visiting teams' video crew.
- b) One school camera per team.

## 8. HALF TIME

- a) Half time performances by drill teams and /or cheerleaders must end three minutes before the start of the second half. The half time will be ten minutes long.
- b) Noisemakers or anything having to do with obnoxious noises, including balloons not used for decorative purposes, are not permitted in the gym before or during the basketball game.

## 9. MUSIC

- a) Live music and/or taped music can be played during pre-game, half-time, and time outs. It will not be permitted any time the clock is running.
- b) No bands are to play in the gym during the course of a game. Before the game and during halftime are the only exceptions.

#### 10. PARTICIPANTS

a) Only officially dressed personnel may lead or participate in any activities on the gym floor prior, during, or after the game.

#### 11. TIME SCHEDULE

- i. Boys and Girls Freshmen, J.V., and Varsity games will be played at opposite sites on Tuesday and Fridays with times starting at 5:30, 6:30, and 8:00 p.m. If no freshman team, JV will start at 5:00/5:30 followed by Varsity 6:30/7:00 or at mutually agreed upon times. (\*Times will be 5:30pm/6:30pm/8:00pm for 3 teams / 5:30pm/7:00pm for 2 teams)
- ii. During the holidays, starting times for district games can be moved to earlier in the day upon mutual consent of the schools involved. The home team will be designated to convey information to the rest of the schools in the district, the officials, and the local newspapers of any rescheduling of games for the above reasons.
- iii. The halftime for Freshman and J.V. games will be 7 minutes. Halftime for Varsity will be 12 minutes.
- iv. Shoot around will be allowed with the following regulations:
  - 1. wearing varsity game shoes
  - 2. only on their designated goal
  - 3. with one of the coaches supervising
  - 4. Allow a reasonable amount of time during the halftime for the floor to be swept
  - 5. During Varsity halftime no unauthorized personnel will be allowed on court.
- v. In cases where conflicts arise due to school related issues, by weather or public disaster; the two schools involved may reschedule their game on the next playable date. Any rescheduling of games for the above reason must be conveyed to the rest of the schools in the district

### 12. START DATE

- a. The first day of practice for the girls will be 10/18/2023 and 10/25/2023 for the boys.
- b. The first day of scrimmages for the girls will be 10/28/23 and 11/4/23 for the boys.
- c. The first day of inner school games for the girls will be 11/3/23 and 11/10/23 for boys.
- d. District certification for the girls will be 2/10/2024 and 2/17/2024 for the boys.
- e. Basketball schedules will be flipped the second year.

## 13. TROPHIES

a. The championship (co-champion) trophy will be purchased by the District Committee.

#### 14. ALL DISTRICT TEAM

- a. All Head Basketball coaches will meet on a time mutually agreed on by the Athletic Directors at the last place team site.
- b. The head coach will be allowed to bring one assistant to the meeting. The Athletic Director of the District Champion shall be in attendance. An All-Academic Team will be selected. All varsity athletes from each school with a minimal GPA of a 90 will be selected. All District selections will not be released until all District teams have been eliminated from the playoffs.
- c. If a representative from the respective school is not present for all district selection, no nomination or vote will be accepted.
- d. Use a District nomination ballot. Any player receiving votes on any of the specialist awards will automatically receive the honorable mention award if not selected for another award. Coaches are not allowed to vote for their own players.
- e. Positions to be selected for basketball are as follows:
  - i. Most Valuable Player
  - ii. Newcomer of the Year Must be 1<sup>st</sup> year varsity player and play half of district season
  - iii. Offensive Player of the Year
  - iv. Defensive Player of the Year
  - v. 6th Man Award- can only start half of a district schedule
  - vi. 1st team- Select 6 Ties Stay -
  - vii. 2<sup>nd</sup> team Select 6 Ties Stay -
  - viii. Honorable Mention Each school may add deserving players
  - ix. All Academic: GPA of 90 or better
  - x. Coach of the Year (winning coach of the district)
- \* TIES WILL RESULT IN CO MVP, NEWCOMER, OFFENSIVE, AND DEFENSIVE PLAYERS OF THE YEAR.

## 15. CONCLUSION OF THE GAMES

- a. Teams will shake hands immediately after the game. Pregame and post-game gestures of sportsmanship should be conducted between teams and sports and contest officials.
- b. Teams will follow post game procedures for the safety of athletes, coaches and officials.

#### 16. ELIGIBILITY

a. Eligibility will be based on the state adopted guidelines of UIL high school competition.

## 17. SUB VARSITY GAMES

- 1. 1. Junior varsity and freshman teams will play a complete schedule with the Varsity teams on Tuesdays and Fridays or mutually agreed upon.
- 2.) Ties for places stand, as there will be no playoffs at the sub varsity levels.
- 3.) Junior varsity and freshmen games will be **8**-minute periods and will run on regulation time. Coaches may mutually agree on reducing the amount of time per period or running clock in the event that games are running behind schedule.
- 4.) Eligibility will be based on the state adopted guidelines for UIL high school competition.

- a) Best won-lost percentage district record to be declared champion.
- b) Second best won-lost percentage district record to be declared second place winner.
- c) Third best won-lost percentage district record to be declared third place winner.
- d) Any tie can be resolved by a coin flip by mutual agreement.
- e) If there is a two-way tie and one team has won both mutual matches, then that team is designated "first seed" for playoff purposes. The other tying team will be designated "second seed." Both teams shall be declared co-champions.
- f) If there is a two-way tie and each tying team has won a mutual game, the two teams may flip a coin to decide the seeding or may play a tie-breaker game to decide the seeding. If both coaches do not agree on flipping or playing, a coin flip will be used to decide. The winner will be designated as "first seed." Both teams will be declared co-champions. The schools concerned will arrange playoff factors. There will be a one game playoff.
- g) If there is a two-way tie for second place and each tying team has won a mutual game, the two teams may flip a coin to decide the seeding or may play a tie-breaker game to decide the seeding. If both coaches do not agree on flipping or playing, a coin flip will be used to decide. If there is a two-way tie and one team has won both mutual matches, then that team is the district second seeded team. The other team would be the third representative.
- h) If there is a multiple tie among three or more schools, there will be a district playoff tournament to determine the first and second seed representative. However, if one team is undefeated in those mutual games among them, that team will represent the district as the "first seed." The same principle will apply to the remaining teams. (This will be known as the "won all mutual games" principle.) In the case of no team having won all their mutual matches, then the tournament playoff format shall be applied. Teams involved will be recognized as district champions. Mutual agreement flips. Refer to "I" for mutual agreement flip procedure.
- i) If three teams tie for first (e.g. A, B, C): Flip to determine by with odd man drawing the bye.
  - 3. "A" draws a bye, "B" plays "C". "C" defeats "B". "C" plays "A" and "A" wins. "A" is the first-place seed and "C" is the second-place seed with "B" being the third place team.
  - 4. "A" draws a bye, and "B" plays "C". "C" defeats "B". "C" plays "A" and "C" wins. "C" is declared the first-place seed, but "A" must play "B" to declare the second-place seed. Winner of "A" and "B" will be declared second place and loser will be declared third place.

## DISTRICT 32-AAA BASEBALL PLAN 2023-2024

1. Play-off Structure – Refer to page 10 of the Athletic Plan (Head to Head Records For Play – Off Purpose)

### 2. Game times will be as follows:

- A. Tuesday DOUBLEHEADER game-JV-5:00 Varsity -7:30 pm. If mutually agree upon 4:30
- B. Friday DOUBLEHEADER game –JV-5:00 Varsity 7:30 p.m. If mutually agreed upon 4:30
- C. Teams may play JV Games on Monday/Saturday if mutually agreed by the two schools.
- D. If no JV game scheduled, the Varsity game will begin at 6:00 p.m. OR LATER IF MUTUALLY AGREED UPON.
- E. Saturday games TBA
- F. ANY TIME CHANGES WILL BE REPORTED TO THE DISTRICT CHAIR WHO WILL NOTIFY THE REMAINING SCHOOLS IN DISTRICT.

## 3. In and Out Workout Format:

Pre-game infield/outfield practice will be as follows:

- A. The home team will take infield 30 minutes prior to game time.
- B. The visiting team will take infield 18 minutes prior to game time.
- C. The pre-game conference with the umpires will take place 6 minutes before the game followed by the National Anthem.
- D. Infield routines shall be restricted to 10 minutes per team.
- 4. Rain Out Games (No Game Played or Started)-National Federation Rules apply.

- \*\* NOTE: It is the responsibility of the home team to make all arrangements with media, officials, administrators, etc. Time or rescheduled game must adhere to the 32-AAA District Plan for Baseball (section 2a, 2b, 2c, 2d & 2e). If the game time must be changed due to unforeseen circumstances all 32-AAA athletic directors must be notified.
  - A. National Federation Rules shall apply in all district games. If field conditions are unplayable due to weather conditions, a decision may be made by the Athletic Directors/Administrators/Coaches on duty of the participating schools as soon as possible.
  - B. In the first round of district play, if the home field is unplayable, the site shall be reversed to the visitors' home field, thus the next round shall be reversed. If the rain out occurs in the second round, the game may be played on the next available date at the home team site designated by the home team. The game may be played at a neutral site designated by the home team. In the 2<sup>nd</sup> round if the home site is again unplayable, a neutral site may be used if it mutually agreed upon by both schools. If the two schools involved cannot agree on the next available date, the DEC will vote on the next available date and the game will be played within the next seven days according to the UIL Baseball Plan. It is the responsibility of the home team to make all arrangements with officials and administrators and to notify all of the 32AAA Athletic Directors of changes in dates, times, and sites.
  - C. Four and one-half innings if the home team is ahead, or five innings if the visiting team is ahead, will constitute a completed game except for power failures. (See D)
  - D. If officials suspend a game (30-minute delay) due to power failure or darkness the game must be continued if possible or played on the next available date. The game will resume from the point of suspension with every effort to obtain the same officials. If the same officials are not available, the chapter assigning secretary will assign new officials.
  - E. If a game is suspended due to weather, it will resume from point of suspension on the next available date. See C: (What constitutes a complete game)
- 5. **A forfeit** will be declared 30 minutes after the scheduled starting time (not enough players or other circumstances) unless coaches have made contact to explain the extenuating circumstances. The final score will be 7 0.

## 6. Officials / Officials "no show"

- A. Varsity games require a two-man crew from R.G.V. If only one umpire shows, the game will be played only by mutual agreement of the two coaches. If the coaches do not agree, they must adhere to 32-AAA Baseball Plan rule 5-A. For sub-varsity games, local SBOA, or a coach from the home school can umpire. JV games must be played if possible.
- B. If there are no officials for a game, the game needs to be played on next available date. Coaches will determine the next available playable date and adhere to the UIL rule.
- C. If a scratched official shows up to call, the school that scratched the official has the option of rescheduling the game for the next available date. The school must have documentation of the scratch and the date scratched. A list of officials from each chapter shall be submitted to the District Chair and District opponents before the first district game. Scratches must be made by **February 1, 2023**. Additional scratches may be added and submitted to District Chair and all District opponents.
- 7. **Ties:** (Varsity) Ties will be played out on an agreeable date/next playable date in accordance to National Federation rules. JV ties will remain.

#### 8. **District Title/ Tie Breaker**

The District Champion will be the team with the best record. The team with the second-best record will be the District Runner-up. The team with the third best record will advance as the Third-Place team as well as the fourth-place record as the Fourth Place Team.

- A. Two-way Tie: If one team has won both head to head competitions during district games, that team will be declared the higher seed. If two teams split their district series, both teams will play a one game playoff and the winner will be declared the seed unless both teams agree to settle the tie with a coin flip. The two teams shall play the one game playoff at a neutral site.
- B. Three-Way Tie: If one team has won majority head to head competitions during District Games (triple round robin schedule), that team will be declared the higher seed. If there is a three-way tie, tied teams will draw for places A, B, C and play a tournament as follows:

  A draws a bye: B plays C and C wins: C plays A. If A wins, A is the highest available seed, C is the next available seed and B is the lowest seed. If C wins, C is the highest available seed, A plays B to determine the other available seeds.
- C. Four or more Teams Tied: A tournament will be played with each team drawing for positions. Team A plays Team B (Game 1), and Team C plays Team D (Game 2). Loser of game 1 plays loser of game 2(Game 3). The winner of Game 3 is 3<sup>rd</sup> seed and loser is 4<sup>th</sup> seed. Winner of Game 1 plays winner of Game 2 for 1<sup>st</sup> and 2<sup>nd</sup> seed (Game 4).
- D. Runner-Up Ties: Shall be determined in the same manner as the Championship and all other ties. (1A-C)

## 9. Official Score Keeper

The Home Team will be responsible for keeping the official scorebook. The official scorer shall be a non-student adult 18 years or older. The official score keeper shall be situated in a neutral area clearly away from both dugouts.

- 10. **Official game ball** will be the Diamond D-1 or the Baden 3B Pro NFHS approved for Varsity Games.
- 11. **Time Limit-** Tuesdays: No Junior Varsity inning will begin after one hour and fifty minutes. Drop Dead Rule. Fridays: No Junior Varsity inning will begin after one hour and fifty minutes. Drop Dead Rule. Junior Varsity games may end in a tie. Junior Varsity will have a mercy rule of no more than **three** runs allowed in an inning. Varsity 10 run rule in effect after 5 innings. Varsity 15 run rule in effect after 3 innings, unless mutually agreed upon to keep playing by both schools.
- 12. Admission for contests will be \$3.00 for adults and \$1.00 for students.
  - 13. **District/Regional Track Meet**: No Varsity or JV baseball game will coincide with District Track Meet date. A mutually agreed upon date and time in regards to Regional Track Meet dates.
  - 14. All other rules as listed in the **Constitution and Contest Rules** of the U.I.L. will be followed.
- 15. **All-District selections** Refer to page 11 of the District Athletic Plan. Use a 4 slot nomination ballot.

## DISTRICT 32-AAA 2022-2023 TRACK PLAN

- 1. A trophy will be presented to the district champion as per executive committee policy.
- 2. At the District Track Meet, 4 men coaches and 4 lady coaches from each school will be allowed in the infield area during finals. Plus Athletic Director/ Athletic Coordinator.
- 3. The **district track meet** will begin no earlier than 9:00 a.m. on the designated day (April 1 and April 3 2024.
- 4. The End of the Year JV Meet will also be held April 1 2024.
- 5. The **5** day prior meeting will be held on **Monday** (3/25/2024).
- 6. For organizational purposes only, 5 days prior to each district track meet, the athletic directors will have organizational meetings to discuss items concerning the district track meets. At these meetings, appropriate official entries (junior high, JV, and varsity) will be turned in on official U.I.L. entry forms (with full names) to the meet director. At this meeting, the time of the scratch/add meeting (to be held on the day of each meet) will be determined. This item does not supersede the UIL C&CR and is not a District Executive Committee policy. Under no circumstances will issues related to the item result in disqualification of any student athlete. Middle School/JV may add and scratch on the day of the meet. (only during designated add & scratch)
- 7. The district track meet will be videotaped ~ all running events start to finish.
  - A. A camera will be used at the finish line.
  - B. The meet referee alone will view the tape and his decision will stand on any protests that may arise.
  - C. In case of a protest no medals will be presented until the meet referee makes the final decisions.
  - D. Schools involved in protest must be notified immediately after the protest is filed.
- 8. It is up to the individual coach to check with the meet director on regional qualifiers at the end of the varsity district track meet. There will be a head track coaches' meeting with the meet director at the completion of the district meets.
- 9. JV- Each school is allowed 3 competitors and 2 relays for each event.

- 10. No baseball/softball games will be scheduled on the dates of the district track meet.
- 11. Each School will have the option of using their own starting blocks or the blocks provided by the host school.
- 12. Relays:
  - A. All participants will be listed at the scratch meeting the day of the district track meet.
  - B. Relay cards are mandatory in all relays 400 M. Relay, 800 M. Relay, and 1600 M. Relay. The card must include full names and the name of the school.
- 13. The pole vault event will follow Track Federation Rules:
  - A. The athlete must not weigh more than the weight specified on the pole.
  - B. A roped off area must be provided to keep out spectators and coaches.
- 14. Any student athlete participating in the district track meet must wear school colors and be using school issued equipment.
- 15. The district track meet directors are responsible for securing all the following officials.

#### ATTENTION COACHES, ATHLETIC DIRECTORS, ADMINISTRATORS:

Any student who participates in a U.I.L. athletic activity must be an amateur and in compliance with Section 441 of the U.I.L. Constitution. This means a tennis player cannot receive free equipment, reduced-price equipment or equipment on loan. The equipment includes (but is not limited to) rackets, balls, shoes, socks, articles of clothing, duffel bags, strings, etc. The coach is responsible for playing only participants who are eligible by U.I.L. rules.

- 1. Divisions, Entries, Restrictions, Draw Meeting.
  - A. Boy's and Girl's divisions for the district meet:
    - high school boys, singles and doubles
    - high school girls, singles and doubles
    - high school boys' and girls' mixed doubles
  - B. Entries:
    - Varsity: At the district tournament, each school may enter two boys' singles and two girls' singles and two boys' doubles and two girls' doubles teams.
    - Each school will be limited to 2 entries in the main draw. Only these 2 entries will count toward team points.
    - JV will be allowed to enter more than two entries per division

However, a school with extra entries will be allowed to enter 2 extra entries provided that those 2 extra entries play their own teammates to decide which teams move into their school's allotted 2 slots in the main draw.

In case of excessive entries, a separate draw and tournament will be held for these players. This draw will be in addition to the regular main draw.

- C. Deadline:
  - No entries shall be allowed for district tournaments, which are not mailed to or received by the director on or before the tenth day before the first day of the meet. An eligibility list, certified by the principal, must be sent to the district chair prior to the first scheduled contest.
    - Round-robin format will be used; a draw is reduced to 3 entries.
- D. Restrictions:

- a. No girls' team may compete against boy's teams and vice-versa.
- b. No boys or girls will be allowed to compete in both singles and doubles

#### E. Draw meeting:

A meeting will be held the week prior to the district tournament to create the official draw.

Number of matches and sets.

- F. Coaches need to turn in phone numbers to meet directors before the District Tennis Tournament. The Meet Director will call or text the coach when their players are due to play. You will be allotted 7 minutes to get your tennis player on the court ready to play. (Too much time is wasted looking for players). The meet can run effectively without time lapses by using this method.
- Number of Matches and Sets

#### A. Sets:

- a. In all Varsity boys' and girls' matches, the best two out of three sets with additional scoring shall determine the winners.
- b. The 12-point tie break scoring system will operate when the score reaches six games all in any

set.

- b. All sub varsity matches will play a pro set with no added scoring.
- c. Option- No add scoring during inclement weather-requires mutual agreement by coaches.

#### Matches:

- d. A contestant shall not play more than three matches per day.
- e. A minimum of one hour's rest for a <u>Varsity</u> team or <u>Varsity</u> player shall be allowed between the close of one match and the beginning of another. (this does not apply towards JV pro sets)
- 3. Substitutions Scratch and add meeting:
  - A. A scratch and add meeting will be held the morning of the tournament to allow coaches to make changes in their entries.
  - B. All other substitutions shall follow the established guidelines of the U.I.L. as listed in Section 902 of the U.I.L. Constitution.

#### 4. Other Guidelines

- A. Uniforms
- a. Individuals and teams representing their school shall wear school-approved clothing.
- b. The clothing shall be in school colors, similar in design, and have the school identifying logo or name clearly visible.
- c. Hats or visors shall be school issued, or Head Coach approved and worn with the bill forward and in an appropriate manner as determined by the meet director.

#### B. Coaching:

- a. A coach may coach players only during the 90-second change over at the end of added games and during the 10-minute rest period for split sets.
- b. Only the SCHOOL tennis COACHES may coach the players.

- c. The coach must coach in a manner, which does not interfere with play on adjoining courts.
- d. Coaches are **only** allowed on the court during a changeover and/or serious injury to the athlete.

#### C. Point penalty system:

- a. All players are warned prior to the start of the tournament.
- b. 1<sup>st</sup>. offense 1 point
  - 2<sup>nd</sup> offense 2 points
  - 3<sup>rd</sup> offense default match
  - 4<sup>th</sup> offense default match
- c. All penalty points are cumulative throughout the tournament.

#### D. Seeding:

- d. At the district tournament, two entries will be seeded in accordance with current year results, which will be presented to the director at the draw meeting.
- e. Players will not be seeded if accurate details are not presented.

#### E. Judging:

- a. 32-AAA will pay the meet referee \$175 maximum. (plus daily mileage)
- b. The meet director is responsible to secure the meet referee.
- F. Tournament Fees: Court fees will be paid by the District, as needed.
- G. Awards:
  - f. Medals-<u>Top 3</u> for the Varsity, JV and freshman meet.
  - g. 2- 28" Trophies awarded to District Champion.

## DISTRICT 31-AAA 2023-2024 GOLF PLAN

#### GENERAL RESPONSIBILITY

It shall be the responsibility of the host school (Principal or Game Supervisor) to initiate corrective measures at all district golf meets to prevent unusual disturbances from individuals or groups and to prevent the use of noise making instruments.

- 2. METHOD OF DETERMINING DISTRICT CHAMPION
  - A. One-day meet will have an eighteen (18)-hole shotgun format.
  - B. The meet director shall determine the district golf meet schedule.
- 3. MEET DIRECTOR
  - A. 32-AAA Athletic Directors will serve as the Meet Referees.
  - B. The meet director shall be responsible for organizing the district meet.
  - C. Site and date to be set the spring prior.
  - D. The Meet Director shall organize the meet in accordance with U.I.L. Constitution and Contest Rules and District 32-AAA rules.
  - E. The District Tournament will be held no more than two weeks before the District Golf Certification date.
- 4. PROTEST Protests shall be made to the meeting director/ committee, who may seek the advice of the resident pro, prior to starting the next hole and his decision, shall be final. This final decision does not prohibit the filing of a complaint. See general policy Section 1, page 2, Rule 1.
- 5. AWARDS Varsity (Boys & Girls)
  - 2 28" Team Trophies
  - 2 each Individual Medals (Gold, Bronze, Silver) for 1st, 2nd, and 3rd.
- 6. UNIFORMS
  - A. Individuals and teams representing their school shall wear school-approved clothing.
  - B. The clothing shall be in school colors and similar in design.
  - C. Caps and/or visors, if worn, are considered part of the uniform and must be school issued and school colors.
  - 7. Each school in the district will provide the necessary monitors required to accommodate each group that participates in the district tournament.
  - 8. PAIRINGS for the tournament will be determined by the athlete's average handicap.
  - 9. The Monitor is by definition an observer and scorekeeper. The Monitor is NOT there to make rulings or advise the players. The Monitor is there to keep score and observe questions of fact; e.g. *IS THE BALL LOST IN A HAZARD OR OUTSIDE A HAZARD?* The Monitor should be knowledgeable of the sport of Golf and need not be a school employee. Monitor is the Official Scorekeeper.
  - 10. The district will hold a meeting on the Wednesday prior to the district golf meets. The meeting will be used to establish pairings for the district golf tournament and discuss items concerning the tournament.
  - 11. Entries should be provided to the meet director 5 days prior to the tournament.

12. The 10 low scores in the district tourney will be designated as the all-district team, including the MVP.

Newcomer of the Year will be awarded to a first-year varsity golfer

- 13. Monitors for the district tournament will be placed with their pairings by Draw.
- 14. An All-Academic Team will also be recognized to any golfer with a 90 or above average

# DISTRICT 31 – AAA 2023-2024 SOFTBALL PLAN

- 1.Play-off Structure Refer to page 10 of the Athletic Plan (Head to Head Records For Play – Off Purpose)
- 2. Game times will be as follows:
  - A. Tuesday DOUBLEHEADER game-JV-5:00 Varsity -7:00 pm. If mutually agree upon 4:30
  - B. Friday DOUBLEHEADER game –JV-5:00 Varsity 7:00 p.m. If mutually agreed upon 4:30
  - C. Teams may play JV Games on Monday/Saturday if mutually agreed by the two schools.
  - D. If no JV game is scheduled, the Varsity game will begin at 6:00 p.m. OR LATER IF MUTUALLY AGREED UPON.
  - E. Saturday games TBA-Mutually agreed upon times.
  - F. ANY TIME CHANGES WILL BE REPORTED TO THE DISTRICT CHAIR WHO WILL NOTIFY THE REMAINING SCHOOLS IN DISTRICT.
- 2. Rain Out Games (No Game Played or Started)-National Federation Rules apply.
- \*\* NOTE: It is the responsibility of the home team to make all arrangements with media, officials, administrators, etc. Time or rescheduled game must adhere to the 32-AAA District Plan for Baseball

(section 2a, 2b, 2c, 2d & 2e). If the game time must be changed due to unforeseen circumstances all 32-AAA athletic directors must be notified.

- A. National Federation Rules shall apply in all district games. If field conditions are unplayable due to weather conditions, a decision may be made by the Athletic Directors/Administrators/Coaches on duty of the participating schools as soon as possible.
- B. In the first round of district play, if the home field is unplayable, the site shall be reversed to the visitors' home field, thus the next round shall be reversed. If the rain out occurs in the second round, the game may be played on the next available date at the home team site designated by the home team. The game may be played at a neutral site designated by the home team. In the 2<sup>nd</sup> round if the home site is again unplayable, a neutral site may be used if it is mutually agreed upon by both schools. If the two schools involved cannot agree on the next available date, the DEC will vote on the next available date and the game will be played within the next seven days according to the UIL Baseball Plan. It is the responsibility of the home team to make all arrangements with officials and administrators and to notify all of the 32AAA Athletic Directors of changes in dates, times, and sites.
- C. Four and one-half innings if the home team is ahead, or five innings if the visiting team is ahead, will constitute a completed game except for power failures. (See D)
- D. If officials suspend a game (30-minute delay) due to power failure or darkness the game must be continued if possible or played on the next available date. The game will resume from the point of suspension with every effort to obtain the same officials. If the same officials are not available, the chapter assigning secretary will assign new officials.
- E. If a game is suspended due to weather it will resume from the point of suspension on the next available date. See C: (What constitutes a complete game)
- 3. A forfeit will be declared 30 minutes after the scheduled starting time (not enough players or other circumstances) unless coaches have made contact to explain the extenuating circumstances. The final score will be 7 0.
- 4. Officials / Officials "no show"
  - A. Varsity games require a two-man crew from R.G.V./Alice SBOA. If only one umpire shows, the game will be played only by mutual agreement of the two coaches. If the coaches do not agree, they must adhere to 32-AAA Baseball Plan rule 5-A. For subvarsity games, local SBOA, or a coach from the home school can umpire. JV games must be played if possible.
  - B. If there are no officials for a game, the game needs to be played on the next available date. Coaches will determine the next available playable date and adhere to the UIL rule.
  - C. If a scratched official shows up to call, the school that scratched the official has the option of rescheduling the game for the next available date. The school must have documentation of the scratch and the date scratched. A list of officials from each chapter shall be submitted to the District Chair and District opponents before the first district game. Original Scratches must be made by **February 24, 2023**. Additional scratches may be added and submitted to District Chair and District opponents.

- 5. Ties: (Varsity) Ties will be played out on an agreeable date/next playable date in accordance to National Federation rules. JV ties will remain.
  - A. District Title/ Tie Breaker
    - The District Champion will be the team with the best record. The team with the second-best record will be the District Runner-up. The team with the third best record will advance as the Third-Place team as well as the fourth-place record as the Fourth-Place Team.
  - B. Two-way Tie: If one team has won both head to head competitions during district games, that team will be declared the higher seed. If two teams split their district series, both teams will play a one game playoff and the winner will be declared the seed unless both teams agree to settle the tie with a coin flip. The two teams shall play the one game playoff at a neutral site.
  - C. Three-Way Tie: Tied teams will draw for places A, B, C and play a tournament as follows:

A draws a bye: B plays C and C wins: C plays A. If A wins, A is the highest available seed, C is the next available seed and B is the lowest seed. If C wins, C is the highest available seed, A plays B to determine the other available seeds.

- D. Four or more Teams Tied: A tournament will be played with each team drawing for positions. Team A plays Team B (Game 1), and Team C plays Team D (Game 2). Loser of game 1 plays the loser of game 2(Game 3). The winner of Game 3 is the 3<sup>rd</sup> seed and the losing team is the 4<sup>th</sup> seed. Winner of Game 1 plays the winner of Game 2 for 1<sup>st</sup> and 2<sup>nd</sup> seed (Game 4).
- 6. Runner-Up Ties: Shall be determined in the same manner as the Championship and all other ties. (1A-C)
- 7. Official Scorekeeper

The Home Team will be responsible for keeping the official scorebook. The official scorer shall be a non-student adult 18 years or older. The official score keeper shall be situated in a neutral area clearly away from both dugouts.

- 8. Official game ball will be the Dudley Core or the State Tourney Baden Softball NFHS approved for Varsity/ J.V. Games.
- 9. Time Limit- No Junior Varsity inning will begin after 80 minutes. Games will drop dead at 90 minutes. A three-run rule will be imposed with the exception of the last inning. Junior Varsity games may end in a tie. Varsity 10 run rule in effect after 5 innings. Varsity 15 run rule in effect after 3 innings, unless mutually agreed upon to keep playing by both schools.
- 10. Admission for contests will be \$3.00 for adults and \$1.00 for students. Optional pricing not to exceed \$5.00 if reserved seating is available.
- 12. District/Regional Track Meets, Varsity or JV, will coincide with District Track Meet dates or Regional Track Meet dates.
- 13. All other rules as listed in the Constitution and Contest Rules of the U.I.L. will be followed.
- 14. All-District selections Refer to page 11 Of the District Athletic Plan.

  Use a 4 slot nomination ballot.
- 15. ALL-DISTRICT POSITIONS Positions to be selected for softball are as follows:
