- II. President** – Anita Pineda: Welcomed everyone to the Seventh Chapter Meeting. Minutes from the Fifth Chapter Meeting were presented for review.
- III. Secretary's Report** – Mychelle D. Moran prepared and presented the 5th Chapter Meeting Minutes which were also posted on the website. Mr. Juan Garza motioned to approve the minutes with Mr. Manuel Galindo seconding the motion; all agreed, motioned passed.
