**MINUTES**



The Eighth TSVOA Chapter Meeting for the 2021 Volleyball Season was conducted in person at the Hanna ECHS Auxiliary Gymnasium. The meeting was called to order at 6:18 p.m. by Chapter President Anita Pineda. All Executive Board Members were in Attendance.

- I. President** – Anita Pineda: Welcomed everyone to the Eighth Chapter Meeting. Minutes from the Seventh Chapter Meeting were discussed and reviewed.
