- ❖ Must attend 7 of 10 Meetings/Training Sessions - (70%).
- ❖ TRAINING REQUIREMENTS:
 1. All members are Required to attend a minimum of three (3) hours of scrimmages.
 2. Members with **Seven (7) or more years** of experience satisfy their requirement by attending at least **THREE (3) Training Sessions** and **THREE (3) Hours of Scrimmages**.
 3. Members with **Three to six (3-6) years** of experience are expected to attend **FOUR (4) Training Sessions** in addition to their **THREE (3) Hours of Scrimmages**.
 4. Members with **less than three (3) years** of experience are expected to attend **FIVE (5) Training Sessions** in addition to their **THREE (3) Hours of Scrimmages**.
 5. All Members of the Association must comply with Meeting Attendance, Training and Scrimmage Requirements in order to be eligible for Assignment of Matches.
